

ANUGERAH TELENODELA 9 TERMS AND CONDITIONS: BONANZA

Please read these terms and conditions ("Terms") carefully before participating in the Anugerah Telenovela 9 Bonanza ("Bonanza"). By entering the Bonanza, you acknowledge that you have read, understood, and agree to be bound by these Terms.

ORGANIZER

The Bonanza is organized by Yayasan Pembangunan Buku Negara ("Organizer"), located at Safuan Tower, 80, Jalan Ampang, Kuala Lumpur, 50300 Kuala Lumpur, Federal Territory of Kuala Lumpur.

ELIGIBILITY

The Bonanza is open to individuals who meet the following criteria:

- i. Participants must be at least 15 years old.
- ii. Participants must comply with all applicable laws and regulations in their jurisdiction.
- iii. Participants need to vote at least in a minimum of 3 different categories.

ENTRY

- i. The Bonanza begins on 26th May 2023 and ends on 15th November 2023. Entries received before the start or after the end of the Bonanza will not be considered.
- ii. To enter the Bonanza, participants must participate and vote in the online voting for Anugerah Telenovela 9.

FINALITY OF VOTES:

- i. All votes submitted by participants are final and cannot be changed or contested.
- ii. Once a vote has been submitted, it cannot be altered, modified, or revoked.
- iii. Organizer will not entertain any requests to change or reverse votes under any circumstances.

PRIZE

- i. The prize for the Bonanza includes a Perodua MyVi, an all-inclusive* 3-day-2-night trip to Tokyo Japan, 1x Apple iPhone, 1x Samsung Smartphone, 3x Xiaomi Smartphones, total of RM5,000 in cash prizes to be won monthly during the Bonanza period.
- ii. The prize is non-transferable and non-exchangeable.
- iii. The Organizer reserves the right to substitute the prize with an item of equal or greater value at its sole discretion.

WINNER SELECTION

- i. The winner ("Winner") will be selected at random from all eligible entries received during the Bonanza period.
- ii. Participants who submitted a greater number of votes have a greater chance at being selected as a winner.
- iii. A participant selected as a Winner in a specific category of the Bonanza cannot win more than once in that category.
- iv. Only registered voters are entitled to win the Bonanza & guest voters are not entitled to win the Bonanza.
- v. The Winners will be notified via phone call, email and WhatsApp.
- vi. The Winner must respond to the notification within 1 day to claim the prize. Failure to do so may result in disqualification, and an alternative Winner may be selected.
- vii. The Organizer's decision in selecting the Winner is final and binding in all matters related to the Bonanza.

PUBLICITY

- i. By participating in the Bonanza, the Winner agrees to the use of their name and entry details for promotional and marketing purposes without additional compensation, except where prohibited by law.
- ii. The Winner may be required to participate in media appearances and interviews at the Organizer's discretion.

PRIVACY AND PERSONAL DATA PROTECTION

- i. The personal information provided by participants will be collected, used, and protected in accordance with the Organizer's privacy policy and the requirements of the Personal Data Protection Act 2010 (PDPA Act 2010).
- ii. By participating in the Bonanza, participants consent to the collection, use, and disclosure of their personal information for the purposes of the Bonanza, including but not limited to verifying eligibility, contacting the Winner, and delivering the prize.
- iii. Participants have the right to access, correct, or delete their personal data held by the Organizer. Requests for such actions can be made in accordance with the Organizer's privacy policy and applicable laws.
- iv. The Organizer will take reasonable measures to ensure the security and confidentiality of participants' personal information. However, the Organizer shall not be held responsible for any unauthorized access, disclosure, loss, or alteration of personal data.
- v. The Organizer may transfer participants' personal information to its affiliates, partners, or service providers, solely for the purposes of conducting and administering the Bonanza.
- vi. The Organizer will retain participants' personal information for as long as necessary to fulfil the purposes stated in these Terms or as required by law.

GENERAL CONDITIONS

- i. The Organizer reserves the right to disqualify any participant who violates these Terms or engages in fraudulent, unethical, or illegal conduct.
- ii. The Organizer reserves the right to modify, suspend, or terminate the Bonanza at any time without prior notice, for any reason or no reason, including but not limited to technical failures, security breaches, or force majeure events.
- iii. The Organizer is not responsible for any lost, late, misdirected, or incomplete entries, or for any technical or human errors that may occur during the administration of the Bonanza.
- iv. These Terms shall be governed by and construed in accordance with the laws of Malaysia. Any disputes arising out of or in connection with the Bonanza shall be subject to the exclusive jurisdiction of the courts of Malaysia.
- v. By participating in the Bonanza, you agree to comply with these Terms. If you do not agree with any part of these Terms, please do not enter the Bonanza.
